SUBJECT: PUBLIC CAUTION NOTICE REGARDING AN UNRELATED THIRD PARTY OPERATING UNDER A DECEPTIVELY SIMILAR NAME

To our customers, distributors, business partners, regulatory authorities, and members of the general public, this notice is issued by **Toro Pharmaceuticals Private Limited** ("the Company") in the interest of public awareness and to protect our stakeholders from confusion and potential harm.

1. About Toro Pharmaceuticals Private Limited

Toro Pharmaceuticals Private Limited is a duly registered pharmaceutical company engaged exclusively in the wholesale supply and export of pharmaceutical products approved by the Central Drugs Standard Control Organisation (CDSCO), in compliance with the Drugs and Cosmetics Act, 1940 and the Rules made thereunder.

The Company does not operate an online pharmacy or e-pharmacy and does not promote or sell prescription medicines through D2C applications or social media channels. All pharmaceutical products are supplied strictly through legitimate business channels and, where applicable, only against valid prescriptions issued by licensed medical practitioners.

Our official and only website is **www.toroindia.com**, and all genuine communications, products, and transactions bearing our name originate solely from this platform and our verified official contact channels (info@toroindia.com).

2. The Issue

It has come to our attention that an entity operating under the name "**Toro Pharma**", through the website **www.toro-pharma.com**, is using a name, brand presentation, and product packaging that closely resembles ours, leading to confusion in the market. Based on information available to us, this entity is offering for sale anabolic steroids, peptides, SARMs, and GLP-1-related products that do not appear to be approved by the CDSCO, and whose manufacture, marketing, and sale may be in contravention of the Drugs and Cosmetics Act, 1940 and the Rules made thereunder, as well as other applicable laws governing such substances in India.

3. No Affiliation or Association

We wish to categorically state that **Toro Pharmaceuticals Private Limited has no affiliation, association, partnership, or business connection whatsoever** with the entity operating as "Toro Pharma" / www.toro-pharma.com, or with any person or platform acting on its behalf. We do not endorse, authorize, manufacture, supply, or take any responsibility for any product, claim, or transaction made by or through the said entity.

4. Risk to the Public and Our Stakeholders

The similarity in name and branding has led to confusion among customers, partners, and members of the public regarding the source and legitimacy of products being sold. We are concerned that this confusion not only causes reputational harm to our Company but, more importantly, may pose genuine health and safety risks to unsuspecting consumers who purchase unapproved and unregulated substances believing them to be associated with us.

5. Advisory to Stakeholders

We strongly advise all customers, distributors, business partners, and members of the public to:

- Verify any product, communication, or transaction claiming to be from Toro Pharmaceuticals Private Limited **only** through our official website (www.toroindia.com) or our verified contact details (info@toroindia.com).
- Exercise caution before engaging with www.toro-pharma.com or any similarly named entity.
- Confirm the CDSCO approval status of any pharmaceutical product before purchase or use.
- Report any suspicious communication, packaging, or product purporting to be associated with Toro Pharmaceuticals Private Limited to our official contact channels below.
